Basis for Costs

Cities and towns are responsible for sharing in the county's cost of registering voters and maintaining the voter registration file (RCW 29A.08.150). The cost sharing model outlined by State rule portions out cost based on the number of registered voters in each city, town and unincorporated area of the county. The cost per voter rate is calculated by dividing the total cost of registering voters and maintaining the registration file by the number of voters in the county.
